From the Staff...

Policy and Procedure.

As pilots for Wings of Mercy, we know that you all want do do all that you can to help our passengers get to their destinations, and to do so in the most comfortable and convenient manner possible. But there are rules and procedures that are set in place for Wings of Mercy flights that sometimes we can easily forget about.

In a recent situation, a pilot ran into a question from a patient that could easily have lead to operating in a manner that would not meet the established procedures for a Wings of Mercy flight.

Here are some of the pilot's notes from the situation:

"The patient was brought to the airport by her mother and father. The father was expected to be traveling with her, but at the last minute the question was asked if we were coming right back to Grand Rapids and if so, could her mother travel along for the entire trip. I politely responded we could not because the weight and balance had been done for just the patient and her father and the entire luggage. She understood and apologized for asking the question to which I said no apology was necessary. After we were airborne I was thinking about the mother asking to come and my response and then it occurred to me the REAL reason I should have been thinking about was the fact she probably had not signed any waiver and therefore would not be eligible for the flight."

The situation was handled tactfully and appropriately by our seasoned Wings of Mercy pilot and we share it as a reminder that all persons on a Wings of Mercy flight must have a signed waiver on file with the office staff. This policy is in place to protect the legal safety of Wings of Mercy, the volunteer pilots, and the aircraft owners, as are the rest of the policies that are in place.

It is also important to consider policy restrictions that are outside of the Wings of Mercy limitations that a pilot may have on their own aircraft. For example, if you are providing an aircraft in which you will serve as SIC because you don't meet the Wings of Mercy PIC requirements and another Wings of Mercy pilot will be the designated PIC for

the flight, will your insurance coverage be valid? If you have an insurance policy that only allows one designated pilot, does not have an open pilot warranty, or for any other reasons prohibits other pilots to be the PIC of the aircraft, if you are operating under Wings of Mercy policies to designate another pilot as the PIC and you as the SIC, you may be operating in contradiction to your current insurance policy. Which means that if something goes wrong, you may be left without insurance coverage.

It can be frustrating to have to say "No" to a flight for seemingly small and trivial "rules", but these little rules are important. Make sure you consider them all before a flight and always be willing to call our office if you have any questions about whether the flight can or should be conducted in the way proposed.

We are very thankful that Tom and Jimmy could help out on short notice for this wonderful, inspirational young lady.
